Qualified Generator Bonus

The Qualified Generator Bonus is a one-time bonus, paid on each purchase of a **Qualified Generator Pack** and is based on your **Personal Enrollment** tree. A Qualified Generator Bonus "Code" (see chart below) is assigned to each of your personally enrolled Generators and the legs #1, #3 and #4 they create. This code determines the QG bonus payout structure for those legs, for an **infinite** amount of personal enrollee generations. You must be a Qualified Generator to participate in the Qualified Generator Bonus. There are three codes for pay out – Based on the number of personal enrollees:

Qualified Generator Bonus Code	Personal Enrollee* (numbered in the order they were enrolled)	Amount assigned to Qualified Generator Code
QG1	#2, #5, #6	\$40
QG2	#7, #8, #9	\$75
QG3	#10 or higher	\$90

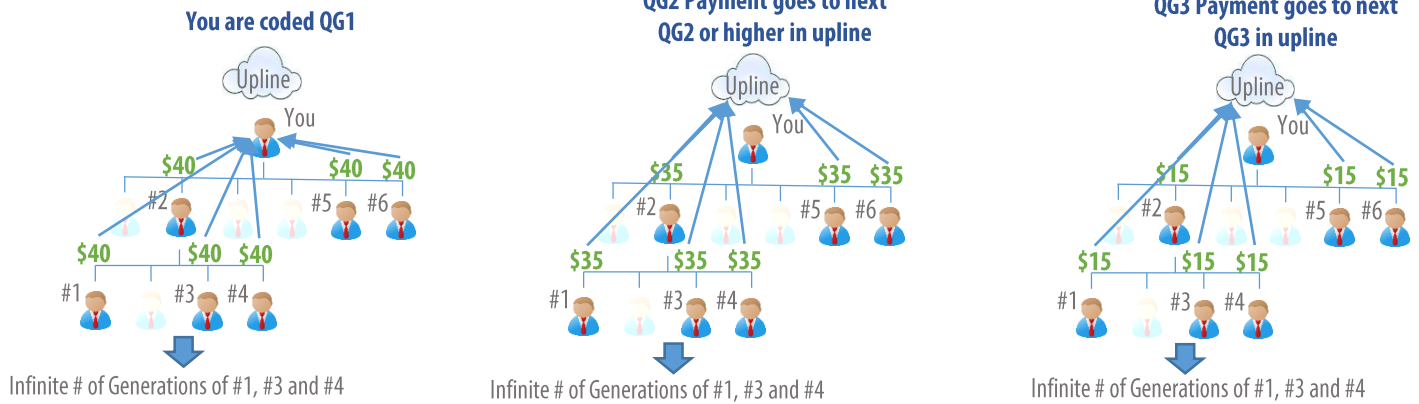
When a purchase happens in your personally enrolled legs that are coded to you

- For your personal enrollee legs #2, #5 and #6, you are paid \$40
- You are also paid \$40 for an infinite number of generations on the #1, #3 and #4 personal enrollees of your personal enrollees #2, #5 and #6
- For your personal enrollee legs #7, #8 and #9, you are paid \$75
- You are also paid \$75 for an infinite number of generations on the #1, #3 and #4 personal enrollees of your personal enrollees #7, #8 and #9
- For your personal enrollee legs #10 and higher, you are paid \$90
- You are also paid \$90 for an infinite number of generations on the #1, #3 and #4 personal enrollees of your personal enrollees #10 and higher

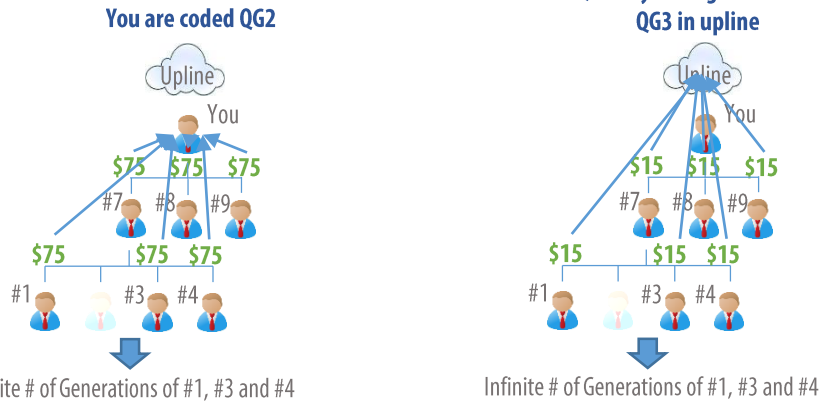
When your downline (legs #1, #3 and #4) are coded QG1 or QG2 for their personal enrollees

- For a leg where the enroller is coded QG1:
 - The enroller is paid \$40
 - The system looks up the enrollment tree to pay \$35 to the first QG2 or higher
 - The system continues to look up the tree to pay \$15 to the first QG3
- For a leg where the enroller is coded QG2:
 - The enroller is paid \$75
 - The system looks up the enrollment tree to pay \$15 to the first QG3

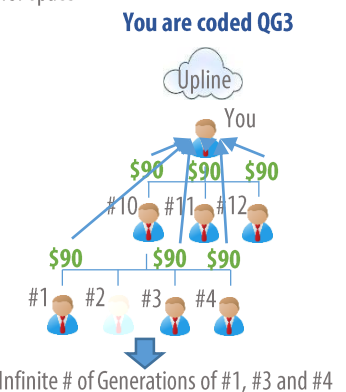
Your Personal Enrollments: #2, #5 and #6 On the legs of your personal enrollee #2, #5 and #6, you receive \$40 on the purchase of a Qualified Generator Pack. You are also paid \$40 on #1, #3 and #4 from the 2nd generation on. The balance is paid to your upline (2nd generation shown only on #2 for space reasons – the same applies to #5 and #6)



Your Personal Enrollments: #7, #8 and #9 On the legs of your personal enrollee #7, #8 and #9, you receive \$75 on the purchase of a Qualified Generator Pack. You are also paid \$75 on #1, #3 and #4 from the 2nd generation on. The balance is paid to your upline (2nd generation shown only on #7 for space reasons – the same applies to #8 and #9)



Your Personal Enrollments: #10 and higher On the legs of your personal enrollee #10, and higher, you receive \$90 on the purchase of a Qualified Generator Pack. You are also paid \$90 on #1, #3 and #4 from the 2nd generation on. There is no balance to be paid to your upline (2nd generation shown only on #10 for space reasons – the same applies to #11 and higher)



* Your Personal Enrollee #1, #3 and #4 are coded to your upline
